All the funds received for the doctor's visit, which includes laboratory tests and medications, is put directly back into the operation of the clinic to care for those in need. The Foundation for Peace works with various pharmaceutical companies, most notably TEVA pharmaceuticals and Novartis Consumer Health, to obtain donations of prescription medications to allow the staff to treat as many of the acute diseases and chronic conditions as possible. Scholarship grants are provided that allow the recipients to pursue degrees from recognized institutions of higher education. Any resident of the Dominican Republic that is already attending an institution of higher education and maintains a satisfactory grade point average ("B" average or better) may apply for the scholarships. The organization's scholarship committee (composed of members of the Board of Directors) determines the scholarship recipients based on the applicants' past academic record, community involvement, and available economic resources (i.e., other potential sources for funding their studies).
