Brisas de los Palmeres is located north of the capital, Santo Domingo, in the Dominican Republic. In 2008, we supported the development of a motorcycle delivery service for their water purification system that significantly increased the number of people drinking clean water. We also partnered with them to initiate construction of a school on top of the church and through continued sponsorship of university students. All in the community are served, regardless of their age, race, religion, or economic status.

4b (Code:) (Expenses \$ 4,207. including grants of \$ 4,207.) (Revenue \$)

Ensanche Quisqueya is located in Santo Domingo proper in the Dominican Republic. It is the location of an elementary school that was built by Foundation for Peace volunteers and that is supported through our student sponsorship program in its efforts to educate about 100 children. Children and their families are served regardless of their race, religion, or economic status.

4c (Code:) (Expenses \$ 2,553,547. including grants of \$ 2,537,914.) (Revenue \$)

During 2008, more than 600 mission team members worked in the DR, Haiti, and Kenya. These groups were composed of participants ranging in age from 6-74 years with many family groups. Over 40% had participated in one or more DR trips previously. They joined together to work hand-in-hand with the Dominicans, Haitians, and Kenyans on 17 construction projects, cared for more than 30,000 patients in medical clinics and distributed tons of educational, health and other supplies to more than 30 communities. Members of local communities were served, regardless of their age, race, religion or economic status.
